**Instructions for bidders:**

The terms and conditions of contract can be downloaded from the website [www.jktenders.gov.in](http://www.jktenders.gov.in) upto said bidding schedule. The bids should be deposited in electronic format on the departmental website [www.jktenders.gov.in](http://www.jktenders.gov.in) upto said biding schedule. The bids uploaded on the website upto due date and time will be

opened online by the tender opening authority in his office chambers on above said date The complete bidding process will be online. The bids for the work shall remain valid for a period of 90 days from the date of opening the bids. Bidders are advised to download bid submission manual from the downloads option as well as from bidders manual kit from the website [www.jktenders.gov.in](http://www.jktenders.gov.in) to acquaint himself in bid submission process. To participate in bidding process, bidders have to get digital signature certificate as per information technology act-2000. The bidders have to submit their bids online in electronic format with digital signature. The department will not be responsible for delay in online submission due to any reason. Scanned copy of cost of tender document in shape of demand draft in favour of the authority prescribed above and earnest money/bid security in shape of CDR/FDR pledged to authority prescribed above must be uploaded with the bid. The original demand draft and relevant documents are to be submitted to the tender receiving authority by registered post /courier/by hand before due date of submission of tenders as per time schedule specified above alongwith GST., Pan No., Regd. Card labour registration dully renewed for the current year.  
Other terms and conditions:-

### **Introduction of work:-**

The main aim of solid waste management which is a sub project of comprehensive management and conservation plan for the Dal - Nageen Lake is to reduce pollution load on Dal Lake. Keeping the above fact in view tenders are invited from the registered *Contractors/ societies/ Non Governmental Organizations (NGO) /Firms* for carrying out the job of solid waste management in the Dal-Nageen lake. The tenders without CDR shall be rejected out rightly. The services envisaged requires day to day collection of solid wastes from the surface of the open water of Dal – Nageen lake, navigational channels / inflow channels/ back waters etc for final disposal by the SMC.

### **Other terms and conditions:**

The successful Contractor/Registered society/ Non Governmental Organization (NGO) /Firm has to submit details of manpower deployment in each zone for which the Contractor/Registered society/ Non Governmental Organization (NGO) /Firm shall fully survey the zones and collect the necessary information before submitting the tender.

1. The period of the job being 12 months, however, the rates are to be quoted as rate per month.
2. The Contractor/Registered society/ Non Governmental Organization (NGO) /Firm shall engage one supervisor for each zone who shall be accountable for providing the service in that zone.
3. However, in case of any complaint from any quarter, if found genuine, the Contractor/Registered society/ Non Governmental Organization (NGO) /Firm will be held responsible and the amount deemed appropriate by the concerned officer shall be deducted from the bill raised for that month.
4. In case of non-availability of transport facility provided by the SMC for transporting of collected waste to dumping site, the Contractor/Registered society/ Non Governmental Organization (NGO) /Firm shall arrange transport for transfer of the collected waste to site identified by LDA on his own and the payment for which shall be made as per actual.
5. The Contractor/Registered society/ Non Governmental Organization (NGO) /Firm is bound to provide gloves, masks and collection bags and equipments to each worker at its own cost.
6. No claim of any labourer for compensation etc, in case of any accidental death or injury while carrying out the job of solid waste management in the Dal-Nageen lake shall be considered by J&K LDA and the Contractor/Registered society/ Non Governmental Organization (NGO) /Firm will exclusively be responsible in such cases.
7. It will be imperative for the Contractor/Registered society/ Non Governmental Organization (NGO) /Firm to provide each collection boat one flag of light sky blue colour having name of LDA inscribed in bold letters on it for identification.

8. The solid wastes shall have to be collected from of open water expanse of 14.18sq.km, settling basin , inflow channels, back waters. In no case the waste shall be left uncollected and it will be the primary duty of the contractor/registered society/ NGO/firm to keep the lake surface free from all solid waste.
9. In addition to regular services the Contractor/Registered society/ Non Governmental Organization (NGO) /Firm shall also have to provide services at the time of religious festivals/ celebrations falling in their zone.
10. The Contractor/Registered society/ Non Governmental Organization (NGO) /Firm will be paid for only a net area of concentration not exceeding 70% of the total area of 14.18sq.km.
11. The Contractor/Registered society/ Non Governmental Organization (NGO) /Firm will have to carry out special drives as and when required and asked.
12. The Registered Society/NGO /firm/contractor shall have to pay the taxes duties, fees, levies and other imposition levied under the existing, amended or enacted laws during life of this contract.
13. The Contractor/Registered society/ Non Governmental Organization (NGO) /Firm will have to provide additional service as per need basis.
