- 1/- The NIT Consisting of qualifying information, eligibility criteria, specifications, bill of quantities (B.O.Q), set of terms and conditions of contract and other details can be seen/downloaded from the Departmental website WWW.jktenders.gov.in upto said bidding schedule.
- 2/- The bids shall be deposited in electronic format on the departmental website www.jktenders.gov.in upto said bidding schedule.
- 3/- The bids uploaded on the website upto due date and time will be opened online by the tender opening authority in his office chambers on above said date and time in presence of the bidders who wish to attend. In case of holidays or office happens to be closed on the date of opening of the bids, the bids will be opened on the next working day at the same time and venue.
- 4/- The complete bidding process will be on line.
- 5/- Bids must be accompanied with cost of tender document in shape of Demand Drafts and earnest money/ Bid security in favour/pledged to the authority shown above.

- 6/- The bids for the work/s shall remain valid for a period of 120 (One hundred twenty) days from the date of opening of bids. However the validity of the tenders can be extended with the mutual consent of the bidders and the tender receiving authority.
- 7/- The earnest money shall be forfeited, if:-
Any bidder /tenderers withdrawn his bid/tender during the period of bid validity or make any modifications in the terms and conditions of the bid or fails to execute the agreement within 28 days after fixation of contract.
- 8/- **Instruction to bidders regarding e-tendering process.** Bidders are advised to download bid submission manual from the “Downloads” option as well as from “Bidders Manual Kit” from website www.jktenders.gov.in to acquaint himself bid submission process.
- 9/- To participate in bidding process, bidders have to get “Digital Signature Certificate (DSC) as per information Technology Act-2000. Bidders can get digital certificate from any approved vendors.
- 10/- The bidders have to submit their bids on line in electronic format with digital signature. No financial bid will be accepted in physical form.
- 11/- Bids will be opened online as per time schedule mentioned above.
- 12/- Bidders must ensure to upload scanned copy of all necessary documents like CDR/FDR/PAN/TIN/Demand Draft/Registration card duly renewed/Sales tax clearance certificate as per Form ST-64/Additional Performance Security Deposit and all documents are to be submitted physically to tender receiving authority upto bid uploading time as mentioned above.
- 13/- The Department will not be responsible for delay in online submission due to any reason. Scanned copy of cost of tender document in shape of demand draft in favour of the authority prescribed above and earnest money/Bid security in shape of CDR/FDR/Additional Performance Security/ pledged to authority prescribed above must be uploaded with the bid. The original Demand Draft (cost of tender document) CDR/FDR (Earnest Money/bid security) and relevant (turnover) documents are to be submitted to the tender receiving authority by registered post/courier/ by hand before due date of submission of tenders/ as per time schedule specified above alongwith TIN No. PAN No/Regd. Card duly renewed for the current year.
- 14/- Bidders may contact office of the undersigned for any guidance for getting DSC or any other relevant details in respect of e-tendering process.
- 15/- Bidders are advised not to make any change in BOQ (Bill of Quantities) contents. In no case they should attempt to create similar BOQ manually. The BOQ download should be used for filling the item rate inclusive of all taxes and it should be saved with the same name as it contains.
- 16/- The unit rates and prices shall be quoted by the bidder entirely in Indian Rupees and the rate quoted shall be deemed to include price escalation and all taxes upto completion/payment of the work unless otherwise, specified.
- 19/- Bidders are advised to use “My Documents” area in their user on e-Tendering portal to store such documents as are required.
- 20/- The tenders receiving authority reserves the right to accept or reject any tender or all tenders without assigning any reason thereof.
- 21/- Any typographical error in terms of items/quantities of the work shall be corrected as per the detailed estimate.
- 22/- Conditional tender of any type or tender volatile of NIT conditions shall out-rightly be rejected, even if the rates quoted are lowest.
- 23/- Photographs of the Pre-execution and post execution of site shall be incorporated with the bill duly signed by contractor/AEE; nothing extra shall be paid to the agency on account of the same.
